1- Students who do not, in the instructor's evaluation, satisfactorily pass their chosen class may, as an option, schedule additional driving training on a lesson by lesson basis for the sum of \$50/hour to be paid in advance of each lesson. 2- The price per appointment is subject to change if there is a lapse of \_\_ days between 2 appointments. 3- Place of training to be given: Greater Charleston, South Carolina area. 4-The length of each in-car lesson is 1 or 2 hours within or teaching area. 5- THAADS, LLC agrees to furnish a car for the instruction along with a qualified instructor, furnishing pick up and a delivery service as a predetermined location. 6- Driving lessons must be canceled AT LEAST 24 HOURS before scheduled time or a \$25 cancellation fee will be charged. 7- THAADS, LLC does not guarantee that the student will receive a driver's license or the SC PDLA form, which is required by law for 15 and 16 year olds to take a driving test. An instructor (based on availability) may accompany any student that the school determines is ready for their road test to the nearest DMV office for the driver's license road test. A license examination fee will be charged for this service based on the time needed for preparation and testing. 8- The vehicle to be used for instruction must have an automatic transmission.
